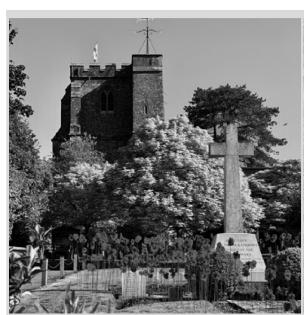

#### **Churchwardens' Report**

2023 saw a complete return to a regular rota of services including some new offerings. In addition to these we hosted 4 baptisms, 2 weddings, 11 funerals, 10 burials of ashes, 3 memorial/thanksgivings, and 4 Ramsbury school services.

#### **Holy Cross Fabric Report**

2023 saw the completion of repairs to the chancel ceiling.

We carried out the regilding of the St Helena altar in time for the coronation of Charles 3rd [last done for the coronation of Elizabeth 2nd 80 years ago].

A faculty for the regilding and renovation of the clock faces and mechanism was finally granted and the contract awarded. The work has now commenced.

Mike and I must thank all those who assist with the running of the church and its upkeep. As usual thanks to Ramsbury Estates for the provision of our splendid Christmas tree.

#### **Holy Cross Churchyard**

The 2023 Annual Sweep-up was at the end of December. We managed to burn most of the leaves, and those which weren't were removed later in six green wheelie-bins.

The same small team of 2-3 worked during the winter on overgrown areas and tidying the spinney.

Removal of Ivy remains an on-going task, to preserve masonry and trees.

Maintenance of 100+ trees continues to be a financial drain, for no tangible benefit, except reducing risk of personal injury to persons in the churchyard. Both London Planes by the Lytch Gate have been pruned (total cost £3,600), and similar work awaits on the Black Pine at the north boundary (£1,600). There remains potential for £2,000-£3,000 to be spent every year on tree-related work.

The churchyard continues to be used intensively by dog-walkers. Three new signs were placed at entrances, inviting people to respect this consecrated ground, but sadly our polite requests are not always respected.

#### **Treasurer's Report:**

Ramsbury & Axford LCC: Year End 31st December 2023

The accounts for 2023 have been independently examined by our accountants (Bew & Co). Our general (unrestricted) Income in 2023 was exceeded by our expenditure by £7,979. There were significant costs incurred in general maintenance of the church and church rooms last year.

In particular, our Church Rooms hire income did not cover the costs for their maintenance and the LCC will review the rates in comparison to the Memorial Hall to ensure that any increase in rates will remain competitive. The deficit in our designated Church Room fund will need to be topped up from our general fund in 2024 to cover ongoing costs.

Our Churchyard required significant work last year in response to the reports from our Tree Surgeon. More work is required in 2024, but we shall look to the Friends of Holy Cross to assist in these costs. We shall also be undertaking work in collaboration with the Fellows (The Old Vicarage) to tidy up our boundary and reposition the gates.

Some of our investments showed a net gain, whilst others resulted in a net loss. The investments that showed a net loss (M&G) are being re-invested in CCLA funds in 2024, as these have proven to give a better return.

The net result is that our total funds have reduced by £7,210 in 2023.

Whilst we have reasonable reserves, this is not a sustainable position going forward. This ongoing annual deficit will need to be addressed by the LCC in the coming year. Full details of our accounts can be found in the Appendix.

We also provided refreshments on 19th August when the Tower was open as part of the LEBRF Open Day. This is a diocesan charity which contributed to the recent overhaul of the Holy Cross bells.

We currently have nine regular ringers and two new trainees. Additional members would be most welcome however!

While they are retiring from this role in 2024, I'm very glad to say that Paula and Barry will continue to help with the cleaning when they can. New members are always welcome, do give us a ring. The Silver Cleaning is undertaken thanks to Carol Howard and Liz Orchard.

#### **Mission Sub-committee Report**

The committee consists of Susie Eliot-Cohen, Jane Handford, Mary Cook, Clemency Ames, Diana Trickey and Jane Sykes.

The annual fund-raising lunch supported Prospect Hospice, suffering a severe funding loss on account of the pandemic. It is our local hospice, located in Wroughton, although its staff will come to people's homes. It has already supported people from the village, in particular Barbara Croucher, an important member of Holy Cross. We raised £2450: they doubled our initial gift. As in the past it was held in Susie's Shoot Room at Hilldrop. The treasurer Paul Trickey kindly arranged the payment to take advantage of the doubling arrangement. This was done in the name of the church but did not pass through the books. We have found this an excellent way of church giving when finances are tight.

Giving directly from the church went to Sarah Gardner's ATE celebrating 10 years work in upcountry Ghana. Sarah, a local girl well known here, in addition to inspiring support from the village here and beyond has been amazingly successful in engaging the local Ghanian community who have made the charity their own. We gave her £500. The other £500 we had to give away went to MAF (Mission Aviation Fellowship) put forward by Ted Hiscocks and known to Mary Cook and Jane Handford from the past. It is a Christian organisation operating more than 100 aircraft over some 25 countries supplying vital needs (food, medical services, water etc.) and Christian missionaries.

#### **Catering Report**

After-church coffees and teas continued to be popular, especially after the Autumn All Souls service. Café Church and Muddy Church were new services for Sunday afternoon. Big thanks to Alison McFee, Liz Nash, Liz Orchard, Tracy Smart and Jen Stoyle plus the many who help with handing round and with washing-up.

There were also many helpers for special occasions – meals for our Notre Dame des Bois visitors and Music in Country Churches performers (special thanks to Jane Sykes), the Carol Service mince pies and mulled wine providers and servers, Christingle oranges assemblers, pancake makers and servers on Shrove Tuesday, plus the September concert drinks and nibbles overseen by Ian Smith, Jane Handford and Liz McIndoe.

#### **Holy Cross Flower Report**

Major changes took place in 2023 as, after many years of excellent service, Jane Handford, Liz Hawes and Mary Cook decided it was time to step down from organising the flowers in Holy Cross Church. Jane sent out letters in summer 2022 via Whitton Ways, Next Door, the Village Diary and the flower ladies group, informing people that unless someone stepped forward there would be no flowers in church. Sadly no-one rushed forward to volunteer until myself, Gilly Doel and Fiona Setter took up the challenge!

2023 was another busy year starting with Easter when the church was adorned with many colourful arrangements as well as jars of daffodils. It smelt wonderful and looked so cheerful.

In May we celebrated King Charles 3<sup>rd</sup> coronation with a Flower Festival. The ladies created some very colourful, gold, red/white/blue arrangements as well as a number of imaginative crowns. Generous donations from visitors boosted the flower fund's account.

September saw the church looking magnificent for Harvest. A spectacular wheat sheaf on the pulpit caused much discussion especially when people found out it was bought from a car boot sale! The Friends of Holy Cross concert goers were also able to appreciate the flower ladies' endeavours.

Remembrance Sunday took place in November with many striking arrangements of poppies.

Holy Cross was once again adorned with wreaths for Christmas. Flower ladies plus villagers brought in the wreaths which looked very colourful. There were also pedestals and window arrangements as well as the pulpit and lectern being wrapped in ivy plus red and gold flowers.

As a new team we felt it was important to provide opportunities for the ladies to meet together so in February we had tea and cake in Holy Cross with Jenny Langton demonstrating ways to create arrangements without the use of oasis. Following this we bought two urns, two large green containers plus a number of different sized Holly Chapple pillows so we could also be part of the movement in churches away from the use of floral foam.

Later in the year we had planned a flower ladies' lunch in Jane Handford's garden but were thwarted by the weather. Nevertheless, the ladies enjoyed a delicious lunch in the Church Rooms with Pimms provided by Ian Smith!

Although we are fortunate in the number of ladies who willingly give their time, expertise and finances in supporting flowers in Holy Cross, we are an ageing community: many of whom are no longer confident or are able to undertake the larger arrangements. This may well have implications for flowers in Holy Cross in the future unless we can encourage younger people to take part.

#### **Work with Children and Families**

"Open the Book" continues in Ramsbury Primary School (the only non-church school in our Parish. With thanks to the volunteers who make this such a success.

Recently, the Ramsbury teams have been performing in the school library due to lack of space elsewhere and only Reception children can fit in the limited space. Hopefully, we will move back into the main hall so that Class 1 can join us again.

This year completed the "Salvation Story" (Year 1: Creation – the Young Church), and embarked on the stories for Year 2, in this, our eleventh year of storytelling. We have almost 40 storytellers across the six teams that cover all of the schools in the Whitton Parish. Following a re-structuring of OTB by the Bible Society, we are still deciding how we move forward – stopping is NOT an option!

Ramsbury school used our church for their "big" services such as Easter, Nativities, Harvest, Leavers,

Easter gardens were built in Holy Cross porch as usual.

Our after-school offering "Flying Fishes ran for a while following Liz Nash's "retirement", but is currently on hold; new leaders are urgently needed!

The new "Muddy Church" sessions that move around the Parish, are still attracting more adults than families, but we hope this will grow as more people understand what it is. We hope to build up resources and helpers for children at mid-morning Communion services – providing conventional "Sunday School" is a problem, but the children do need to feel that they are welcome and that their needs are catered for, even if there aren't many of them.

The "Teddy Bears' Picnic" was held on the 24th September for Baptism and other church families, and the half-dozen families who came all seemed to have a good time, enjoying

the activities and the teddy bear cake, while making new friends! Baptism anniversary cards are delivered for five years.

Walk in the Light, the alternative to Halloween, held on October 31st had a fine evening with 27 adults and approximately 35 children taking part. £42.00 was raised to support Swindon Food Collective. Again grateful thanks to the team of stewards who kept everyone safe.

#### The Friends of Holy Cross

General – the Friends are in fine form as they approach their tenth anniversary with an impressive number of members (some 480), an excellent record of support for the fabric of the church, and another enjoyable selection of events to entertain a wide range of tastes and ages. Looking forward to 2024, a number of new committee members will be bringing fresh ideas and energy to this most beneficial charity.

Events – in April we much enjoyed a concert by the multi-award winning Aldbourne Brass Band; in June the annual garden party held at The Old Mill, by kind permission of Annabel and James Dallas, was blessed with glorious weather; the AGM in July was held, as previously, in Tim and Emma Eliot-Cohen's wonderful garden, again in ideal weather; and the autumn Ramsbury Talks were much appreciated and successful. A further series of talks is planned for 2024 along with a similar programme of other events. One new initiative by the Friends was to take over the running of the village Welcome Pack scheme, and in the process hopefully recruit new members!

Support – the Friends supported the repairs to the Chancel ceiling, a CCTV installation, and currently, the re-gilding of the two clock faces. Looking ahead, it is expected that the Friends will be able to provide support for the re-gilding of the weathervane; some additional work on the church lighting; the better presentation and interpretation of the Saxon stones; and the moves towards net zero carbon for which the Church of England has set some ambitious targets.

Legacies – the Friends are actively encouraging all of us to consider amending our Wills to include the Friends in the list of beneficiaries. The main new lighting project was funded almost entirely by one such legacy.

These accounts have been prepared using the Accruals basis of accounting as required by the Charities Commission and form part of the overall Parish Accounts which are presented at the APCM.

These LCC accounts have been independently examined by our accountants Bew & Co, Marlborough.

#### **Independent Examiner's Report**

This report on the financial statements of the LCC for the year ended 31st December 2023, which are set out on the attached pages, is in respect of an examination carried out in accordance with the Church Accounting Regulations 2006 ('the Regulations') and s. 145 of the Charities Act 2011 ('the Act').

#### Respective responsibilities of the LCC and the examiner

As members of the LCC you are responsible for the preparation of the financial statements; you consider that the audit requirement of the Regulations and s.145 of the Act does not apply. It is my responsibility to issue this report on those financial statements in accordance with the terms of the Regulations.

#### Basis of this report

My examination was carried out in accordance with the General Directions given by the Charity Commission under s.145(5)(b) of the Act and to be found in the Church guidance, 2006 edition. That examination includes a review of the accounting records kept by the LCC and a comparison of the accounts with those records. It also includes considering any unusual items or disclosures in the financial statements and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

#### Independent examiner's statement

In connection with my examination, no matter has come to my attention:
